TERMS & CONDITIONS						

- The statements made by an agent in the Empanelment Form and the declaration made therein shall be the basis of the contract.
- An agent shall carry out such directions and instructions as may from time to time be issued by Canara Robeco Asset Management Company Ltd (AMC) in this regard.
- An agent / or its employees who are engaged in sales and marketing of the products of Canara Robeco Mutual Fund (Mutual Fund) shall be certified by National Institute of Securities Market (NISM) or Association of Mutual Funds in India (AMFI), as the case may be, and hold a valid certificate as required by the Securities and Exchange Board of India (SEBI). Such Certificate shall be submitted by the agent to the AMC for its records and verification.
- An agent is not authorised to issue any receipt for cheques and demand drafts received along with the application forms on behalf of the AMC. The agent shall at no point of time receive cash on behalf of the AMC.
- An agent is eligible for brokerage on the amounts mobilized by him at the rate(s) prescribed by AMC. The rate(s) are subject to revision, from time to time, at the discretion of the AMC and the agent shall be bound by such changes. The brokerage payable shall be inclusive of all taxes, costs, charges and expenses incurred by the agent in connection with the agency.
- The agent declares and covenants with the AMC to defend, indemnify and hold the Trustees of the Fund, the AMC, its affiliates, sponsors, successors and permitted assigns harmless from and against all claims, damages or assertions of liability of any kind or nature resulting from:
 - Any breach of terms, covenants and conditions or other provisions hereof, or offer a) document(s) or any acts of omission or commission there under;
 - Any failure to comply with all applicable legislation, statutes, ordinances, regulations, code b) of conduct, administrative rulings or requirements of law;
 - (ر) The misfeasance, malfeasance or fraudulent acts of the agents or its representatives; and
 - Any and all actions, suits, proceedings, assessments, settlement, arbitration awards, costs and expenses, including attorneys' fees, resulting from any of the matters set forth above.
- The appointment of an agent shall be liable to be terminated by the AMC forthwith:
 - If he/she is found to be a minor or adjudicated as an insolvent or of unsound mind by a a) court of competent jurisdiction;
 - If in course of any judicial proceeding it is found that he/she has knowingly participated or connived in any fraud cheating or misrepresentation against the AMC or any Unit holder of Canara Robeco Mutual Fund.
 - If the AMC is satisfied that any statement made in the Empanelment Form was false or misleading or calculated to mislead;

- If he / she acts in any other manner prejudicial to the interest of the AMC / Mutual Fund; and
- If he / she fails to comply with any applicable legislation, statute, ordinance, regulations, code of conduct, administrative rulings or requirements of law.
- Notwithstanding what is stated in the preceding paragraphs, either party is entitled to terminate 8. the Agency by giving a 10 days notice in writing.
- An agent shall not have any claim against the AMC / Mutual Fund for any loss incurred by him/her 9. due to any revision in the rate(s) of commission.
- An agent must read and understand the Offer Document of the respective scheme(s) carefully and explain the risks, investment objectives and the special features of the schemes to the investors. The agent must not make any representation concerning Units of the Mutual Fund except those contained in the Offer Document of the respective scheme(s), the Key Information Memorandum containing Application Forms and printed information issued by the AMC as information supplemental to such documents.
- The agent must not use or engage in unethical practices to sell, market or induce any investor to buy Units of the Mutual Fund.
- While recommending any Scheme to an investor, the Agent shall disclose to such investor all the commissions (in the form of trail commission or any other mode) payable to him for different competing schemes of various mutual funds.
- In case of application by non-individuals, a certified true copy of the relevant resolution or authority to make the application as the case may be, along with a certified true copy of the Memorandum and articles of Association / Bye-laws / Partnership Deed and Certificate of Registration should be submitted.
- The agent shall use only such Offer Documents, Key Information Memorandum containing Application Forms and advertising material as provided by AMC and the agent shall not design its own advertisement of the scheme(s) of the Mutual Fund unless it has obtained prior approval in writing from the AMC
